## Processing framework and origin of the data

### Purpose and legal basis for processing

#### Visitor data:

We are obliged to document your presence in our company in order to protect you and our employees and for reasons of traceability as quickly as possible of potential infection chains with the new type of virus Covid-19 ("Corona"). Collection, processing or use of personal data are only made to comply with safety measures of the health protection and infection prevention due to the corona pandemic.

## Legal basis:

- legal basis according to Sec. 6 (1) lit. c GDPR
- Health Protection in accordance with §22 Abs. 1 (1) lit. c BDSG
- Infection Protection Law
- consent in accordance with Sec. 6 (1) lit a GDPR

## Categories of personal data, which is processed:

- company
- first name, surname

# Origin (source) of the data

The data stored was collected as part of an announcement of the visitor by the relevant employee. Usually, this is done through e-mail contact or a telephone call where you are referred to the fact that in case of a visit we will collect the data and document in a digital list temporarily.

# Recipients (categories) of personal data

**Public bodies:** public health department only if requested by the public health authority, police

**Internal bodies:** The entry into a visitors' list on our inhouse server is done digitally by the appropriate employee who is responsible for the visitor.

**External bodies:** Transmission to external bodies does not take place.

# Transmission in third countries

Transmission of personal data outside the European Union does not take place.

# Duration of storage / deletion

The data will be deleted or destroyed after four weeks.

## Rights of the person concerned

- get information concerning the data stored in relation to your person (Sec. 15 GDPR)
- correction, if wrong personal data is processed (Sec. 16 GDPR)
- deletion and restriction as well as contradiction against the data processing (Sec. 17, 18 and 21 GDPR)
- revocation of consent (Sec. 7 (3) GDPR). As a result of this, we stop the data processing that was based on your consent.
- right of appeal to the supervisory authority (Sec. 77 GDPR)

## Withdrawal of consent

Every person concerned has the right within the meaning of Sec. 6 (1) lit. a or Sec. 9 (2) lit. a to withdraw individual or all the consents which have been granted at any time and without any disadvantage for himself, without this affecting the legality of the processing carried out on the basis of the consent until the withdrawal.
